WHEREAS


- (A) The Assignor created a design for a water powered clock ("the Design"). Representations of the Design are annexed hereto in Attachment A.

IT IS AGREED as follows:



2. This Assignment shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region and the parties hereby submit to the non-exclusive jurisdiction of the courts of Hong Kong Special Administrative Region.

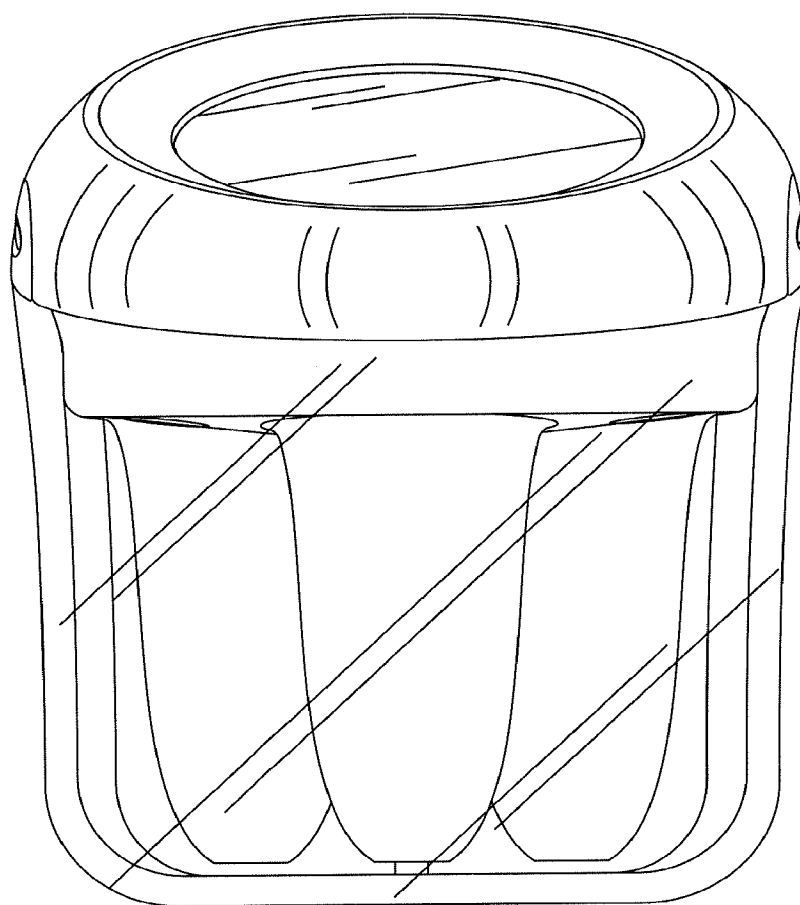
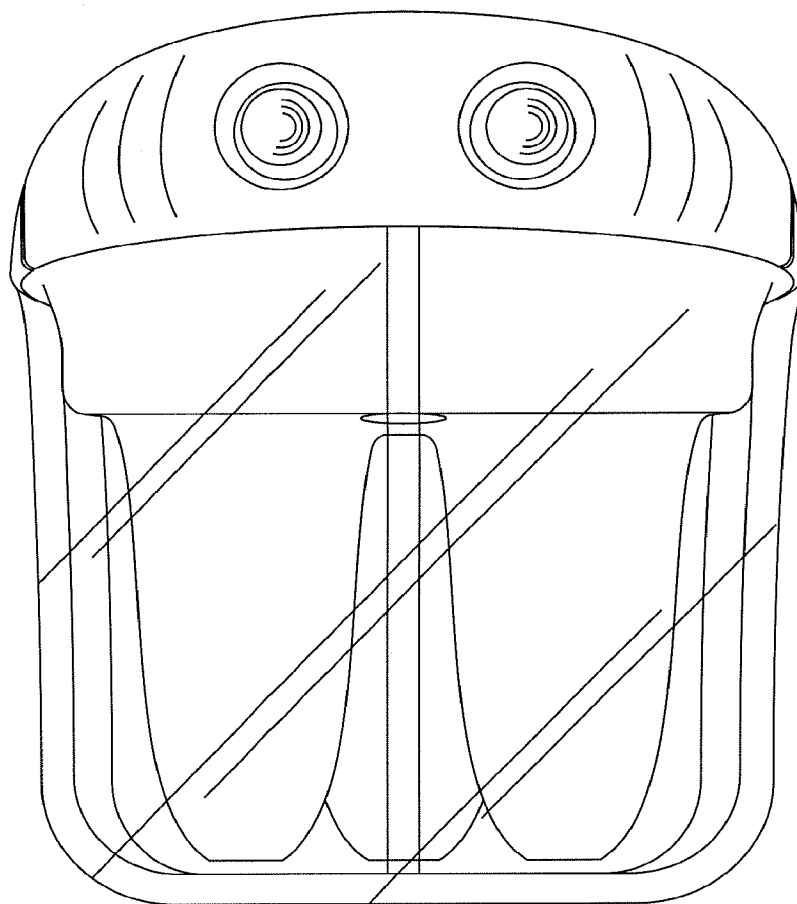
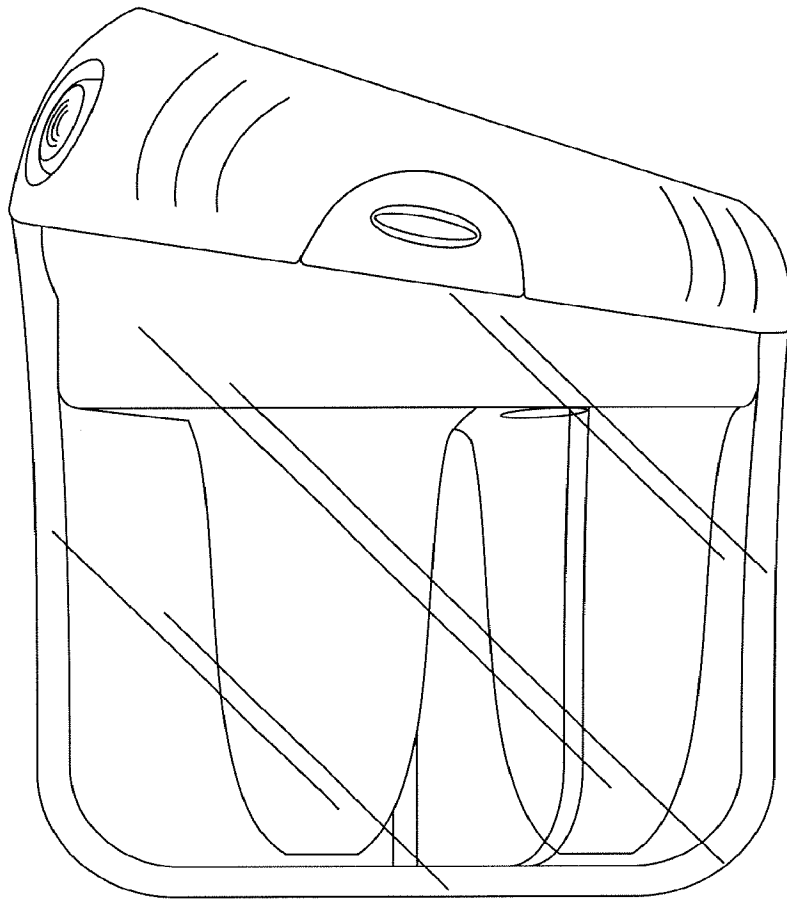


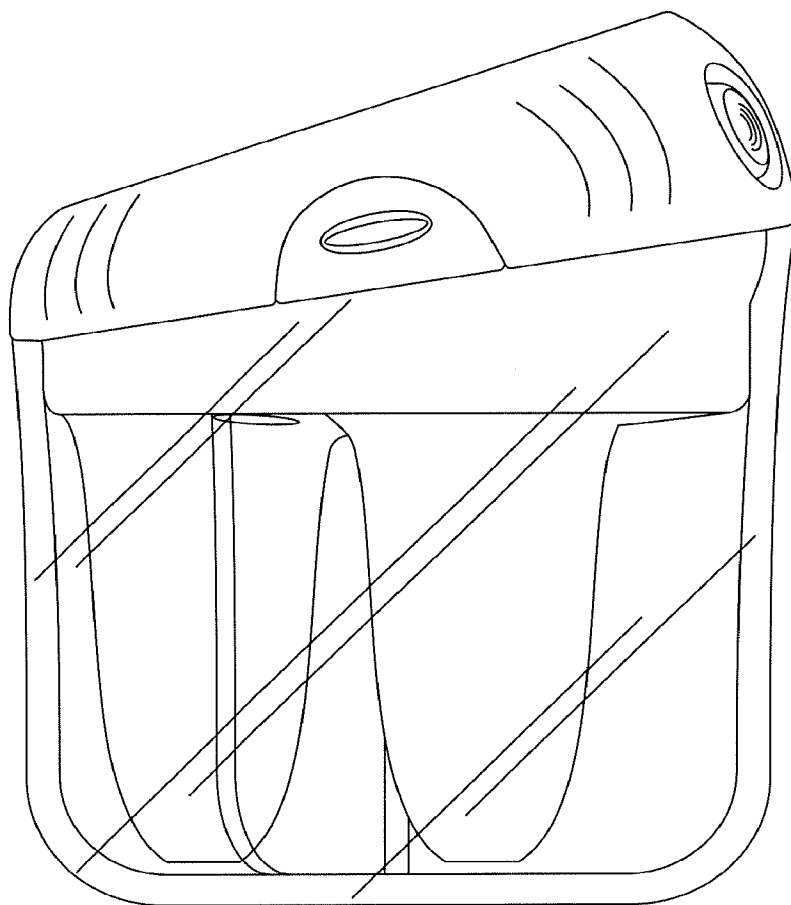

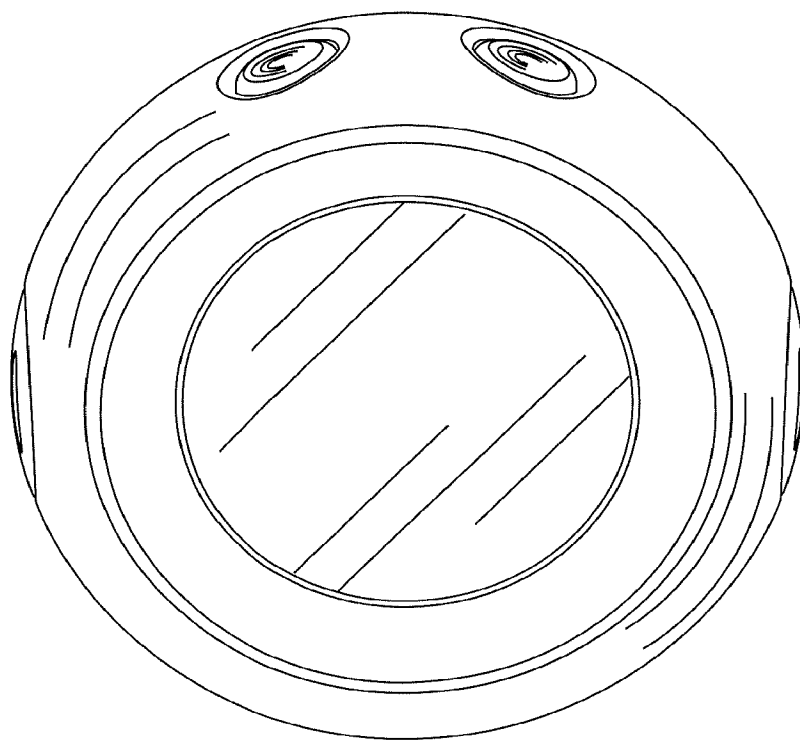

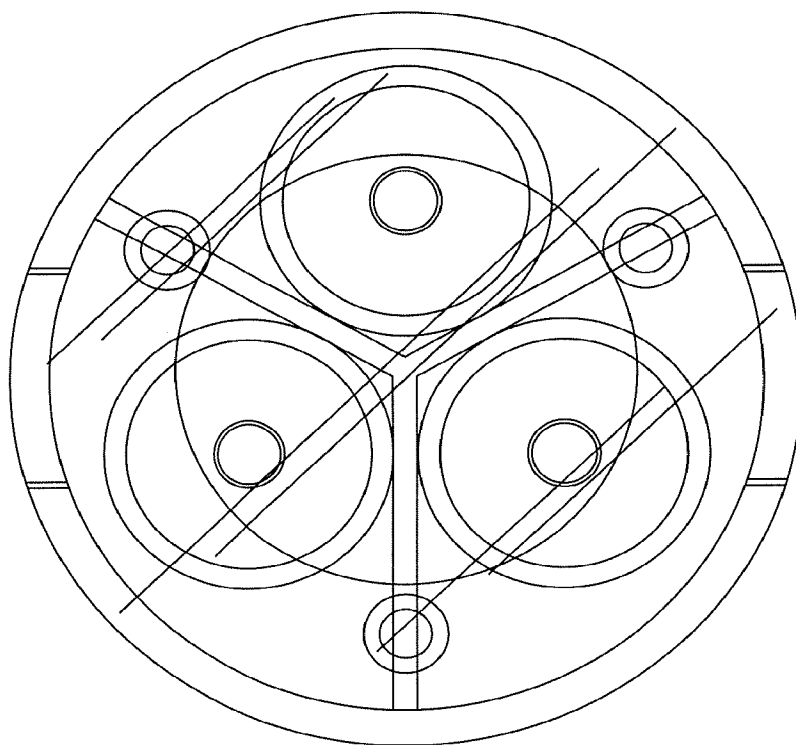

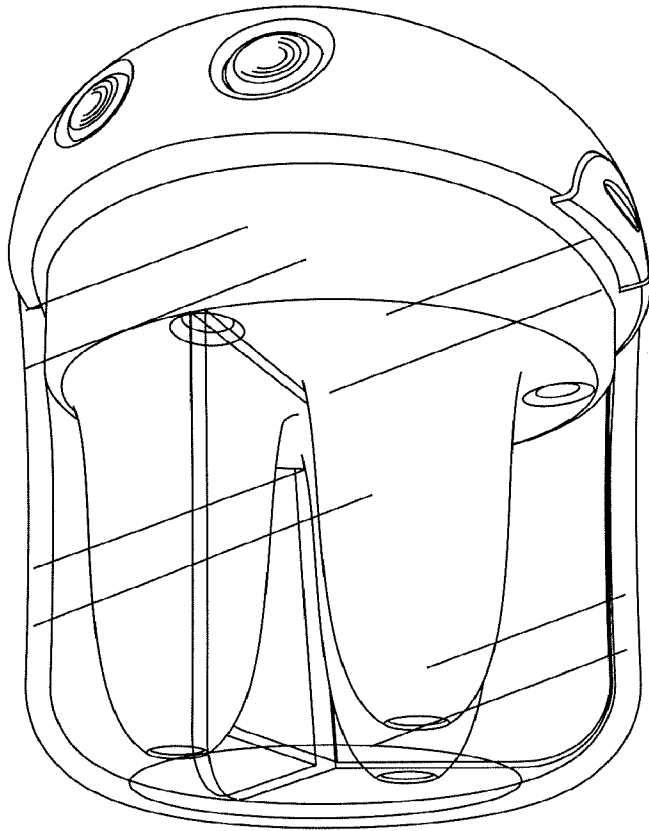

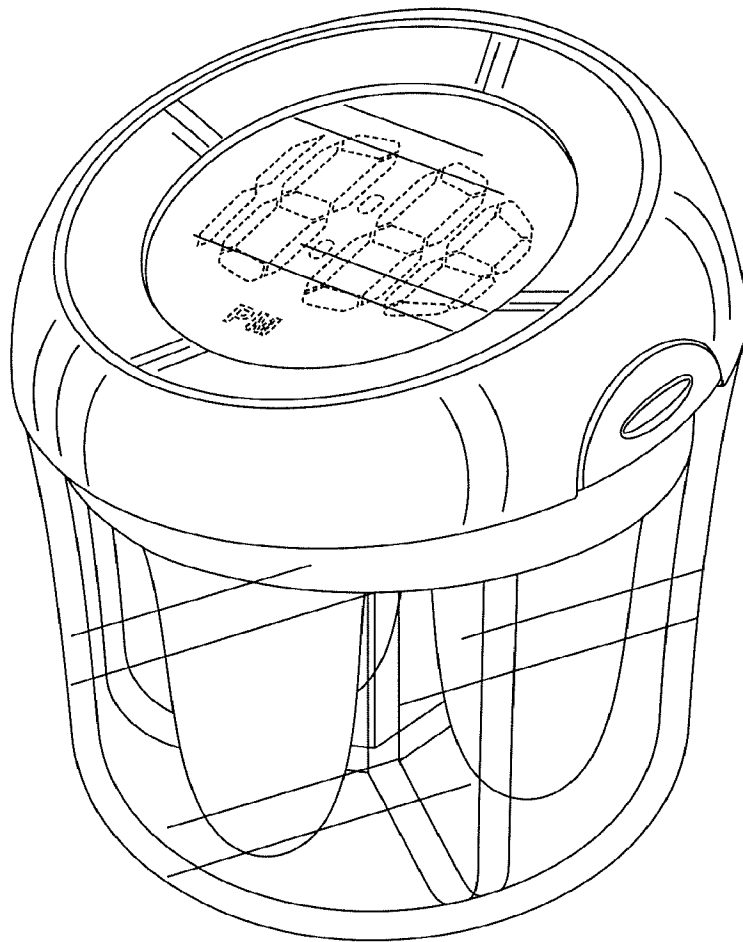
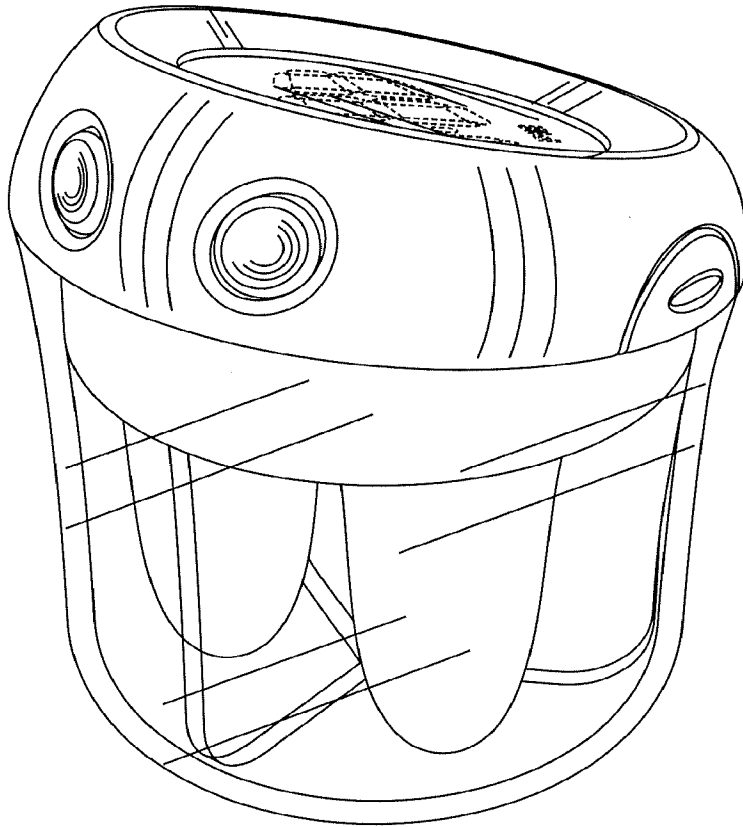
