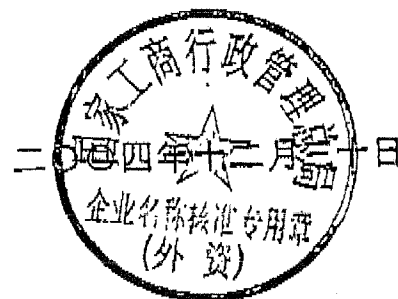

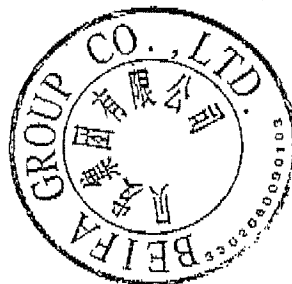

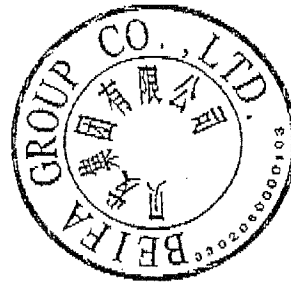

Footnote:

1. This notice will expire at the end of the effective date. If there is a proper reason that an entity did not complete the name change registration, and the effective date need to be postponed, the entity must apply to postpone the effective date 1 month before the original effective date through a registration agency. The effective date cannot be postponed for more than 6 months.
2. When an entity registers for name change, the registration agency must keep this notice in the entity's file.
3. If an entity's name changing involves other legal or administrative regulations, the entity must apply for proper examination and approval. Without the examination and approval from relevant agencies, the registration agency cannot change entity's name based on this notice.
4. Within 30 days after an entity changes its name, the registration agency should keep in file the copy of the entity's business license, and the copy of the enterprise registration certificate. Without those in file, the name of the entity is not protected.
