NOW, THEREFORE, in consideration of the foregoing statements and for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all right, title and interest in the United States and throughout the world, in, to and under said improvement and inventions and all patent applications, patent rights, and inventor's certificates thereof, therefore and therein, including without limitation said Patent Application Publication in the United States, all divisions and continuations thereof, all right to sue for infringement, all patents which may be granted for said improvements and inventions by the United States, or states or nations other than the United States, or by other authority, entity, or organization, and all applications therefore, have been and are hereby sold, assigned, transferred, and delivered unto Assignee, its successors and assigns; and it is covenanted and agreed by the undersigned, and for executors, administrators, and legal representatives of the undersigned, that at Assignee's request

any and all applications, affidavits, oaths, declarations, assignments, and other instruments will be made, executed, and delivered as may be necessary, or desirable to secure for or vest in Assignee, its successors or assigns, any improvement, inventions, right title, interest, application, patent, patent right, reissue right or other right or property covered by this assignment, and the United States Commissioner of Patents and Trademarks is hereby requested and authorized to issue any and all United States patents granted on any of said applications, including said Borge Application, to assignee as owner of the entire right, title, and interest in, to, and under the same, and appropriately empowered officials of foreign countries are hereby authorized to issue any letters patent granted on any of said applications and patents, including said Borge Application, to Assignee as owner of the entire right, title and interest in, to and under the same.
