Wagering Game For Tracking Various Types Of Wager Inputs

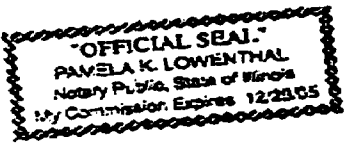
