

## PATENT LICENSE AGREEMENT

This patent license agreement ("License Agreement") is made and entered into as of June 1, 2007 (the "Effective Date"), by and between ALIVE Tech, Inc., a Georgia corporation (the "Licensor"), and Big Stage, Inc., a Delaware corporation (the "Licensee").

### RECITALS

WHEREAS, Licensee desires to obtain an exclusive license to U.S. Patent 7,103,211 owned by Licensor in the Licensed Field (as defined below), and Licensor is willing to grant a exclusive license to Licensee in the Licensed Field, on the terms and conditions set forth in this License Agreement.

### SECTION 1

#### DEFINITIONS

1.1 "Licensed Field" the field of digital display applications and display communications including, without limitation, video games, gaming and conferencing, social networking, email, instant messaging, greeting cards, advertising, entertainment, virtual environments, toys, personalized content and retail sales.

1.2 "Licensed Patent" means U.S. Patent 7,103,211.

1.3 "Licensed Patent Rights" means U.S. Patent 7,103,211 and parent patents or parent patent applications, any continuations, continuations-in-part, and divisional applications and patents issuing thereon, and reissued patents, renewals, reexaminations, or extensions thereof, and foreign counterparts, divisional patents and continuations of any of the foregoing throughout the world.

1.4 "Licensed Rights" means the Licensed Patent and the Licensed Patent Rights.

### SECTION 2

#### PAYMENT, LICENSE GRANT AND REPRESENTATION

2.1 One-Time Payment. In consideration for the rights granted hereunder, Licensee shall pay to Licensor, by wire transfer upon execution and delivery of this License Agreement, a one-time license fee in the amount of one hundred thousand dollars (U.S. \$100,000).

2.2 Grant of Rights. Subject only to receipt of the payment described in Section 2.1,

Licensor hereby grants to Licensee an exclusive, perpetual, worldwide, irrevocable, fully-paid up, royalty-free, license, without right to sublicense (except as provided in this Section 2.2), under the Licensed Rights to practice all methods or processes claimed or covered thereunder and to make, have made, use or sell, resell, offer to sell, export, import or otherwise use, transfer or dispose of any and all products or services, and to sell any and all products and services and license any and all products and services covered thereby in each of the foregoing cases for uses in the Licensed Field. No rights to sublicense are granted hereunder, except that (i) Licensee may use distributors, resellers, and partners to exercise the rights granted to Licensee in this License Agreement with respect to Licensee's products and services, and (ii) Licensee may grant end users licenses to use products or services under the Licensed Rights.

**2.3 No Other Rights Granted and Notice of Other Licenses.** Subject to the grant of rights to Licensee pursuant to Section 2.2, all other fields of use are reserved to Licensor, including, without limitation, identification of humans using facial biometrics for physical and logical access control, surveillance, identification management and video analytics. Licensor agrees to notify Licensee in writing of any other licenses granted under any of the Licensed Rights, identifying the licensee and the field of use.

**2.4 Representation and Warranty.** Licensor hereby represents and warrants that it has not previously granted any rights under any of the Licensed Rights in the Licensed Field to any third party and that it has not itself exercised any rights under the Licensed Rights in the Licensed Field. Licensee's sole remedy in the event of a breach of the foregoing representation by Licensor are that, upon Licensee's request following any such breach, Licensor will promptly refund all amounts paid hereunder by Licensee. In the event of any such payment, the license granted hereunder and all other terms hereof will remain in full force and effect.
