**EXHIBIT 3.2(c)(ii)**

**PATENT ASSIGNMENT AGREEMENT**

This Patent Assignment Agreement ("**Patent Assignment**") is entered into as of Closing Date by and between Clairvoyante, Inc., a California corporation ("**Seller**"); and Samsung Electronics Co., Ltd., a corporation organized under the laws of the Republic of Korea ("**Purchaser**"). "**Closing Date**" shall have the meaning set forth in the Asset Purchase Agreement ("**Agreement**") between Purchaser and Seller.

**WHEREAS**, Seller and Purchaser are parties to that certain Asset Purchase Agreement dated as of March 21, 2008 (the "**Purchase Agreement**"), pursuant to which Purchaser has agreed to purchase from Seller the Purchased Assets (as defined in the Purchase Agreement);

**WHEREAS**, pursuant to the Purchase Agreement, Seller has agreed to assign certain rights and agreements to Purchaser, and Purchaser has agreed to assume certain obligations of Seller, as set forth herein, and this Agreement is contemplated by Section 3.2(c)(ii) of the Purchase Agreement;

**NOW, THEREFORE**, for and in consideration of the premises and the mutual covenants contained herein, and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

**1. DEFINITIONS**

1.1 "**Patents**" shall mean all United States and foreign patents and utility models and applications therefor and all reissues, divisions, re-examinations, renewals, extensions, provisionals, continuations and continuations-in-part thereof, and equivalent or similar rights anywhere in the world in inventions and discoveries, as particularly set forth in the Purchase Agreement and as listed on Schedule A.

1.2 "**Registered Intellectual Property**" means all United States, international and foreign Patents.

1.3 "**Closing Date**" shall have the meaning set forth in the Purchase Agreement.

**2. ASSIGNMENT**

2.1 **General.** Seller hereby transfers and assigns to Purchaser all right, title and interest in and to the Patents. The foregoing assignment also includes: (a) all of Seller's right, title and interest in and to any and all causes of action and rights of recovery for past infringement, or misappropriation of the Patents; (b) all notes, manuals, drawings, specifications, descriptions, formulae, models, prototypes or computer programs which incorporate any part of, or are or were derived from, or are or were created, produced or used in association with any Patent; and (c) all trade secrets, license rights, agreements, processes and confidential information associated with the Patents owned by Seller, including without limitation all rights

of Seller to receive royalties and other rights of Seller under any licenses or any similar agreements existing on the Closing Date.

**2.2 Further Assurances.** Upon request by Purchaser at any time, and at Purchaser's cost and expense, Seller shall execute all documents and instruments and do all other things deemed necessary or useful by Purchaser in establishing, perfecting, protecting, prosecuting, defending and enforcing Purchaser's proprietary right, title and interest in the Patents, at Purchaser's expense.

**2.3 Attorney in Fact.** Where Purchaser is unable because of Seller's unavailability, dissolution, mental or physical incapacity, or for any other reason, to secure Seller's signature to apply for or to pursue any application for any United States or foreign Patent or mask work registration or copyright registrations covering the Patents, then Seller hereby irrevocably designates and appoints Purchaser and its duly authorized officers and agents as Seller's agent and attorney in fact, to act for and in Seller's behalf and stead to execute and file any such applications and to do all other lawfully permitted acts to further the prosecution and issuance of such Patent and mask work registrations, or copyright registrations thereon, with the same legal force and effect as if executed by Seller.


