2. Article I of the Amended Articles of Incorporation of this Corporation, which presently reads as follows:

"One: The name of this corporation is Self repairing Computers, Inc."

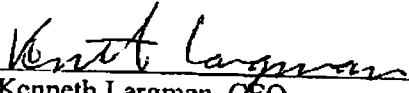
shall be amended in its entirety to read as follows:

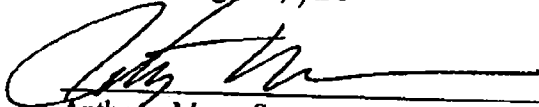
"One: The name of this corporation is Vir2us, Inc."
