ASSIGNMENT AND CO-OWNERSHIP AGREEMENT

WHEREAS, Catherine Cannon ("Cannon") and Melissa Mia Kain ("Kain"), citizens of the United States of America, residing at 5641 Carleton Road, Mariposa, California 95338 and 1525 State Road 37, Mulberry, Florida 33869, respectively, have invented certain new and useful improvements in EROGENOUS STIMULATOR, which is the subject of an application for United States Letters Patent entitled EROGENOUS STIMULATOR filed concurrently herewith;

for said invention, or patents resulting therefrom, insofar as their interest is concerned, to the Assignees.

Likewise, the Assignors also hereby sell and assign to the Assignee, their successors and assigns, their foreign rights to the invention disclosed in said application, in all patent-granting countries of the world, including the right to file applications and obtain patents for said invention in their own names in said countries and including all rights of priority in said countries under the terms of the International Convention for the Protection of Industrial Property, and the Assignors further agree to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such patent rights.

The Assignors also hereby agree, at the request and expense of the Assignees, to testify in any legal proceedings, sign all lawful papers, make all lawful oaths, and generally do everything possible to aid said Assignees, their successors and assigns, to obtain and enforce proper patent protection for said invention in all countries.

The Assignors also hereby grant Robert C. Kain, Jr., Reg. No. 30,648 the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.

Cannon and Kain hereby agree that they are co-owners of the patent rights that are the subject of this Assignment, that any future assignment, sale, or license (hereinafter referred to as a "disposition") of these patent rights must be with the written approval and consent of both coowners, and that this Agreement makes any disposition by either of the co-owners without the express, written approval of the remaining co-owner void and null as a matter of law.

Cannon and Kain hereby agree that if they both do not approve, in writing, of a disposition of the patent rights, then both co-owners will submit the dispute to binding arbitration in Orlando, Florida which shall be conducted under the Rules of the American Arbitration Association (AAA) by a single arbitrator mutually agreed upon by both co-owners. The decision reached by the arbitrator as to the disposition of the patent rights shall be binding upon both co-owners and enforceable by a court having jurisdiction of the parties.
