WHEREAS, Amosense Co., Ltd , 185-1, Sucham-ri, Tongjin-myun, Kimpo-shi, Kyungki-do, KOREA, (hereinafter called "Assignee"), was previously assigned one half (50%) of the entire right, title and interest in the Intellectual Property by Assignor;

Assigns, transfers and conveys, to Assignee, Assignor's remaining one half (50%) of the entire right, title and interest together with the benefits and privileges in and to said inventions and discoveries, said Letters Patents or similar forms of protection of the United States of America, and all other applications for Letters Patent on said inventions and discoveries in whatsoever countries, including all divisional, renewal, substitute, continuation and convention applications based in whole or in part upon said inventions or discoveries, or upon said application, and any and all Letters Patent, reissues and extensions of Letters Patent or similar forms of protection granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Letters Patent;

2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to issue or transfer all ownership in said Letters Patents to Assignee, as assignee of all (100%) of the entire right, title and interest therein, or otherwise as Assignee may direct; and

3. Warrants that it has not knowingly conveyed to others any rights in said inventions, discoveries, applications or patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or discoveries, except for the previous conveyance of one half (50%) of the entire right, title and interest in the Intellectual Property to Assignee; and that it has good right to assign half (50%) of the entire right, title and interest in the Intellectual Property to Assignee without encumbrance.
