

CONFIRMATORY ASSIGNMENT

This Confirmatory Assignment ("Assignment") shall be effective as of July 22nd, 2005 ("Effective Date") by and between:

NICOLAS CONSTANTIN, residing at 249 rue Allion, Lasalle H8P2C6, P.Q., Canada ("ASSIGNOR"); and

SKYWORKS SOLUTIONS, Inc. having a principal place of business at 5221 California Avenue, Irvine, CA 92617, USA ("SKYWORKS").

1.0 BACKGROUND

1.1 ASSIGNOR, through his employment with SKYWORKS, as either employee or contractor, as the case may be, invented certain new and useful improvements as described and set forth in an application for Letters Patent of the United States titled "DYNAMIC BIASING SYSTEM FOR AMPLIFIER", Serial No. 11/102,472 filed on April 8, 2005. The subject matter of this patent application shall be referred to as the "Invention."

1.2 SKYWORKS, as employer of ASSIGNOR, owns all right, title and interest in and to the Invention. ASSIGNOR, as consideration for his employment with SKYWORKS, agreed to execute all the necessary documents in order to perfect and confirm SKYWORKS's ownership in any inventions created or developed by ASSIGNOR during his employment with SKYWORKS.

1.3 For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR is executing this Assignment in order to confirm SKYWORKS's ownership in and to formally transfers to SKYWORKS all right, title and interest in and to the Invention and all Letters Patent which may be granted from the Invention in the United States or any foreign country.

2.0 ASSIGNMENT

2.1 ASSIGNOR sells, assigns and transfers to SKYWORKS, effective as of the Effective Date first set forth above, the full and exclusive right, title and interest in and to the Invention, all patent applications related to the Invention, and all Letters Patent which may be granted from the Invention in the United States, including any continuation, division, renewal, substitute or reissue thereof for the full term or terms for which the patents may be granted.

2.2 ASSIGNOR also assigns all of his right, title and interest in and to the Invention in all foreign countries, including the right to apply for a patent in any foreign country and the right to all current and further applications for patents for the Invention, including the right to claim International Convention priority.



The terms, covenants and provisions of this Assignment shall inure to the benefit of SKYWORKS, its successors, assigns and other legal representatives, and shall be binding upon ASSIGNOR, his heirs, legal representatives and assigns.
