### METHOD AND APPARATUS FOR PARTITIONING A COMPUTER CLUSTER THROUGH COORDINATION POINT DEVICES

4. Said Assignors hereby warrant and represent that they have not entered and will not enter into any assignment, contract, or understanding in conflict herewith.


