**ASSIGNMENT**

WHEREAS, **JOHN P. MATEOSKY AND MICHAEL Y. FRANKEL** (hereinafter referred to as "ASSIGNORS ") have invented certain new and useful improvements in an invention entitled:

**HIGH-SPEED OPTICAL TRANSCEIVER FOR INFINIBAND AND ETHERNET**
