
NUNC PRO TUNC ASSIGNMENT

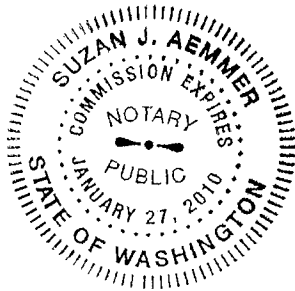
