DETECTING EDGES IN A DIGITAL IMAGE

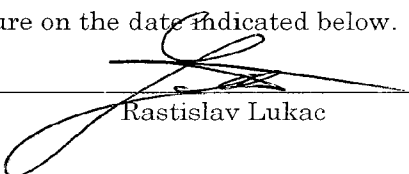
