said improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof.

I do hereby covenant and agree, for myself, my heirs and my legal representatives, that I will assist said, in the prosecution of the application herein identified; in the making and prosecution of any other applications for Letters Patent that said **Assignee**, may elect to make covering the invention herein identified, as hereinbefore set forth; in vesting in said **Assignee**, like exclusive title in and to all such other applications and Letters Patent; and in the prosecution of any interference which may arise involving said invention, or any application or Letters Patent herein contemplated; and that we will execute and deliver to said **Assignee**, any and all additional papers that may be requested by said **Assignee** to fully carry out the terms of this assignment.

And I do hereby authorize and request the Commissioner of Patents to issue all Letters Patent of the United States that may be granted pursuant to application aforesaid, or for said invention, to said **Assignee**, its successors and assigns in accordance with this assignment.

And I hereby covenant that I have full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith.
