ASSIGNMENT OF INVENTION AND PATENT APPLICATION

THIS ASSIGNMENT OF INVENTION AND PATENT APPLICATION (the "Assignment") is executed and delivered as of March 26, 2007, by Miche Bag, LLC, a Utah limited liability company ("Assignor") to MCM Holdings, LLC, a Utah limited liability company ("Assignee").

RECITALS

WHEREAS, Assignor has agreed to sell, transfer, convey, assign and deliver to Assignee, all right, title and interest in, to and under certain intellectual property pursuant to the terms and provisions of that certain *Intellectual Property Assignment Agreement*, dated March 26, 2007, by and among, Assignee, Assignor, Annette B. WHEREAS, this Assignment is being executed and delivered in order to effect the transfer of all of Assignor's right, title and interest in and to (i) that certain method and apparatus entitled "Systems and Methods for Customizing Handbags," hereinafter called the "Invention," and (ii) the patent application identified on Exhibit A hereto (the "Patent Application").

(b) any and all forms of intellectual property protection derivable from the Patent Application, and that are derivable from any and all continuing applications, reissues, extensions, renewals and reexaminations of the Patent Application, including, without limitation, corresponding applications filed in countries foreign to the United States, and in all patents issuing thereon in the United States and foreign countries; and

(c) the right to file foreign patent applications on the Invention in Assignee's own name, wherever such right may be legally exercised, including the right to claim the benefits of the *International Convention for such applications*.

all such ownership, rights, title, and interest to be held by Assignee for Assignee's own use and enjoyment and for the use and enjoyment of Assignee's successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor agrees that, without additional consideration, it will take such further actions and execute promptly such further documents as are necessary to effect and record the above assignments, including any actions or documents required by the applicable registrar or other official to document the transfer herein or as may be necessary to protect, secure, and vest good, valid, and marketable title to the Patent Application and the Invention and any and all related rights and interests in Assignee.

Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States and subordinate or other officials, and any official of any country foreign to the United States whose duty it is to issue service patents or other evidence or forms of intellectual property protection or applications, to issue the same to Assignee and Assignee's successors, assigns, and other legal representatives in accordance with this instrument.
