BILL OF SALE

For good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound hereby, HAUSER, INC., a Delaware corporation ("Hauser" or the "Seller"), does hereby unconditionally and irrevocably sell, convey, grant, assign and transfer to PHENOLICS, LLC ("Buyer"), its successors and assigns, all of the Seller's legal, beneficial and other right, title and interest in and to the Berry Assets, as such term is defined in the Sale Motion described below, including, without limitation the inventory listed on Schedule 1 attached hereto and the United States and foreign patents and patent applications listed on Schedule 2 attached hereto.

The Seller, for itself and its respective successors and assigns, hereby covenants and agrees that, without further consideration, at any time and from time to time after the date hereof, it will execute and deliver to Buyer such further instruments of sale, conveyance, assignment and transfer, and take such other action, all upon the reasonable request of Buyer, in order more effectively to sell, convey, grant, assign, transfer and deliver all or any portion of the Purchased Assets to Buyer and to assure and confirm to any other person the ownership of the Purchased Assets by Buyer.

Nothing contained in this Bill of Sale shall in any way supersede or in any way affect the terms and conditions of sale set forth in the "Motion for Order Authorizing the Sale of the Berry Assets to Phenolics, LLC" (the "Sale Motion") filed by Hauser in its Chapter 11 bankruptcy case (the "Bankruptcy Case") currently pending in the United States Bankruptcy Court for the Central District of California (the "Court") or in the "Order Authorizing the Sale of the Berry Assets to Phenolics, LLC Free and Clear of all Liens, Claims and Encumbrances" (the "Sale Order") entered by the Court in the Bankruptcy Case on September 29, 2004 nor shall this Bill of Sale expand or enlarge any remedies under the Sale Motion or the Sale Order. This Bill of Sale is intended only to effect the transfer of the Berry Assets sold and purchased pursuant to the Sale Motion and the Sale Order and shall be governed entirely in accordance with the terms and conditions of the Sale Motion and the Sale Order.


Terms used herein and not defined have the meanings assigned to them in the Sale Motion and the Sale Order.
