
WHEREAS, the Patentee is the sole owner of said Patents;

WHEREAS, Robert and Lisa Vito (hereinafter referred to as the "Assignees") whose mailing address is 143 Viburnum Drive, Kennett Square, PA 19348, were granted a First Priority Security Interest in the said Patents by the Patentee, as evidenced in the Patent and Trademark Security Agreement between Robert & Lisa Vito and the StingFree Technologies Company (hereinafter referred to as the "Security Agreement");



NOW, THEREFORE, pursuant to the Security Agreement executed on the 29 day of FEBRUARY, 2008, the Patentee does irrevocably assign and transfer unto said Assignees the entire right, title and interest in and to the said Patents, to be recorded by the Assignees upon the Patentee's material Default under the Security Agreement ("Default" as defined therein), the Patents to be held and enjoyed by the said Assignees for their own use and behoof, and for their legal representatives and assigns, to the full end of the term for which said Patents are granted, as fully and entirely as the same would have been held by Stingfree Corporation had this assignment and sale not been made.




