RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (this "Release") is made as of July 2, 2008 ("Effective Date") by and between Manufacturers and Traders Trust Company (successor-in-interest to Allfirst Bank), a New York corporation ("Lender"), and Ann's House of Nuts, Inc., a Maryland corporation, with its principal office at 8375 Patuxent Road, Jessup, Maryland 20794 ("Assignor").

WHEREAS, pursuant to the terms and conditions of that certain Collateral Assignment of Patents as Security dated October 2, 2001 (the "Patent Security Agreement"), Assignor granted, assigned and conveyed to Lender all of its present and future right, title and interest in and to, and granted to Lender a continuing security interest in, Lien (as defined in the Security Agreement) on, and collateral assignment of, the Patents (as defined in the Patent Security Agreement), including, without limitation, the United States patents set forth on Schedule A attached hereto, together with all of the Assignor's rights, title and interest in and to (a) any and all inventions and improvements described and claimed in such Patents and patent applications, (b) reissues, divisions, continuations, renewals, extensions and continuations-in-part of any Patents and patent applications, (c) income, royalties, damages, claims and payments now or hereafter due and/or payable under and with respect to any patents or patent applications, including, without limitation, damages and payments for past and future infringements, (d) rights to sue for past, present and future infringements of patents, and (e) all rights corresponding to any of the foregoing throughout the world ("Patent Rights");

WHEREAS, Assignor and Lender entered into the Patent Security Agreement pursuant to the terms and conditions of that certain Third Amended and Restated Loan and Security Agreement by and among Grantor and Lender dated October 2, 2001 (the "Security Agreement");

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on October 4, 2001 at Reel/Frame 012243/0269, and

WHEREAS, Assignor has paid all of its outstanding indebtedness to Lender.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates the Patent Security Agreement and Security Agreement, and hereby grants, assigns and conveys to Assignor all of its rights, title and interest in the Patents and Patent Rights, and terminates, cancels and releases any and all security interests or Lien it has against the Patents and Patent Rights.

Lender shall, at Assignor's expense, take all further actions, and provide to Assignor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Assignor to more fully and effectively effectuate the purposes of this Release.
