
NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

Automotive Components Holdings, LLC, further covenants to execute all additional instruments and to do all things necessary for carrying out the purpose of this instrument, at the expense of said Ford Motor Company, and its successors.
