We hereby acknowledge that this assignment, being of our entire right, title and interest in and to said inventions, carries with it the right in E INK to apply for and obtain from competent authorities in all countries of the world any and all Letters Patent by attorneys and agents of E INK's selection and the right to procure the grant of all Letters Patent to E INK for its own name as E INK of our entire right, title and interest therein.

AND, we hereby further agree for ourselves and our executors and administrators to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the aforesaid invention to said E INK, its successors, assigns, and legal representatives, but at its or their expense and charges, including: the execution of applications for patents in foreign countries; the execution of substitution, reissue, divisional or continuation applications; and preliminary or other statements or the giving of testimony in any interference or other proceeding in which said inventions or any application or patent directed thereto may be involved;

AND, we do hereby authorize and request the Commissioner of Patents of the United States to issue such Letters Patent as shall be granted upon said application or applications based thereon to said E INK, its successors, assigns, and legal representatives.


