WHEREAS

(A) The Assignor is the inventor of an invention relating to **DATA TRANSMISSION METHOD** (hereinafter referred to as "the Invention") which is the subject of an International Patent Application No. **PCT/GB2006/004312** filed on **21 November 2006** and designating amongst other countries the United States of America (hereinafter referred to as "the Application")

(B) The Assignor is the applicant for the Application in so far as it relates to the United States of America

2. The Assignor agrees to execute all papers and documents necessary in connection with the Application or any interference which may be declared and any continuing or divisional applications thereof and also to execute separate assignments in connection with such applications as the Assignee may deem necessary or expedient and further to perform any act which may be necessary in connection with claims or provisions of the International Convention for Protection of Industrial Property or similar agreements.
3. The Assignor agrees to perform all affirmative acts which may be necessary to obtain a grant of a valid United States patent to the Assignee.
4. The Assignor hereby authorizes and requests the Commissioner of Patents to issue any and all Letters Patent of the United States resulting from the Application or any division or divisions or continuing applications thereof to the Assignee, as Assignee of the entire interest, and hereby covenants that he has full right to convey the entire interest herein assigned and that he has not executed and will not execute any agreement in conflict herewith.
5. The Assignor hereby grants the firm of MARKS & CLERK the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent Office for recordation of this document
