WHEREAS, JOHN S. AND ASSIGNORS HEREBY authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same for the invention identified above to the Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND ASSIGNORS HEREBY covenant that they have full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, any agreement in conflict herewith;

AND ASSIGNORS HEREBY further covenant and agree that they will communicate to the Assignee, its successors, legal representatives, and assigns, any facts known to it respecting the invention, and testify in any legal proceeding, sign all lawful papers, execute all divisions, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for the invention(s) in all countries.





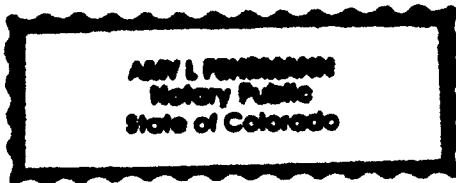
