## LICENSE TO THE UNITED STATES GOVERNMENT

WHEREAS, Alban Linnenbach of Philadelphia, Pennsylvania has invented "Gene Family of Tumor-Associated Antigens" and filed a patent application thereon in the United States, bearing Serial Number 291,583, filing date December 29, 1988, and;

WHEREAS, the invention was made in the course of research supported in whole or in part by grant(s) from the Department of Health and Human Services, and;

WHEREAS, the United States Government is entitled to certain rights in and to said invention and application by reason of the terms of the Institutional Patent Agreement Governing Grants and Awards from the Department of Health, Education and Welfare dated June 6, 1969, and;

WHEREAS, THE WISTAR INSTITUTE OF ANATOMY AND BIOLOGY, hereinafter called the "Licensor" has acquired by assignment from the inventor the entire right, title, and interest of the inventor to such invention;

## NOW THEREFORE:

1. The Licensor, in consideration of the premises and other good and valuable consideration, hereby grants and coveys to the United States Government a royalty-free, nonexclusive and irrevocable license for governmental purposes and on behalf of any foreign government pursuant to any existing or future treaty or agreement with the United States under the aforesaid patent application, and any and all divisions or continuation, and in any and all patents or reissues which may be granted thereon during the full term or terms thereof. As used herein, "governmental purpose" means the right of the Government of the United States (including any agency thereof, state or domestic municipal government) to practice and have practices (made or have made, used or have used, sold or have sold) throughout the world by or on behalf of the Government of the United States.

2. The Licensor covenants and warrants that he has the right to grant the foregoing license, and that any assignment or license which he may make of the invention or the said patent application or patents thereon, shall expressly be made subject to this license.

3. The Licensor agrees that the Government shall not be estopped at any time to contest the enforceability, validity, scope of, or title to, any patent application herein licensed.
