ASSIGNMENT

WHEREAS, I, Yan Liu, a resident of China, and citizen of China, have invented certain new and useful improvements in “**CHANNEL EQUALIZATION IN A RECEIVER**” disclosed in an application for United States Letters Patent filed herewith (United States Patent and Trademark Office on March 28, 2008, and assigned Application Serial No. 12/079,950).
