

ASSIGNMENT

WHEREAS, **Ronald K. Hettinger**, residing at 4239 Alta Vista Court, Oceanside, California 92057, **Thomas R. Hilton**, residing at 2215 Manchester Avenue, Cardiff, California 92007, and **Augustin W.
