HUNTING ACCESSORY HOLDING DEVICES





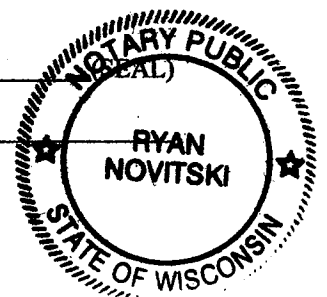
