PATENT RIGHTS ASSIGNMENT

WHEREAS, Nartron Corporation, a corporation of the state of Michigan, having a place of business at 5000 North US 131, Reed City Michigan 49677 (hereinafter Nartron) is the owner of all patent rights in and to inventions entitled FLUID HEATING SYSTEM, and VEHICLE WINDSHIELD CLEANING SYSTEM, as set forth and embodied in three related U.S. patent applications, co-invented by David Shank, John Washeleski, Peter Strom and John Mitchell and one international patent application filed in the name of Nartron, which were filed with the U.S. Patent and Trademark Office and accorded the following patent application serial numbers and filing dates:

- 3) U.S. Patent Application Serial No. 10/894,266, entitled Vehicle Windshield Cleaning System, filed July 19, 2004 in the United States Patent and Trademark Office and assignment recordal to Nartron pending (application pending), and
- 4) International application No. PCT/US2004/028122, entitled Vehicle Windshield Cleaning System, filed 30 Aug 2004 in the name of Nartron Corporation in the United States receiving office (pending)

(the inventions will hereinafter be referred to as "said inventions" and Nartron's patent rights in the invention will hereinafter be referred to as "said patent rights in said inventions");

WHEREAS, SBR wishes to be assigned all rights, title and interest in and to said patent rights in said inventions owned by Nartron, including the right, if and to the extent any such right exists, to file patent applications in the United States and foreign countries to obtain patent protection for said inventions;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties, Nartron hereby assigns, transfers and conveys to SBR all rights, title and interest in and to said patent rights in said inventions, including the right, if and to the extent any such right exists, to file future patent applications in the United States and foreign countries to obtain patent protection for said inventions.
