number 60/266,076, and is entitled CATALOG BUILDING METHOD AND SYSTEM.


AND WHEREAS, Computer Pundits, Inc., a corporation organized and existing under and

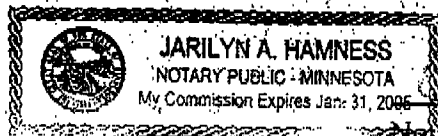


