**ASSIGNMENT**

WHEREAS, WE, LYLE A. BAYS, a citizen of the United States residing at 3620 NE 193<sup>rd</sup> Circle, Ridgefield, Washington 98642; BRUCE J. KOKKO, a citizen of the United States residing at 1270 Symphony Boulevard, Neenah, Wisconsin 54956; MICHAEL A. SCHMELZER, a citizen of the United States residing at 2316 S. Clover Lane, Appleton, Wisconsin 54915; and, GARY L. SCHROEDER a citizen of the United States residing at 1070 Oxford Court, Neenah, Wisconsin 54956 ("Assignors"), have invented certain new and useful improvements in "DUAL MODE INK JET PAPER," for which We executed an application for United States Letters Patent concurrently herewith or filed an application for Letters Patent of the United States on July 11, 2008, and accorded Serial No. 12/171,587 ("Application"); and

AND ASSIGNORS HEREBY authorize and request the Commissioner for Patents or any other proper officer or agency of any country whose duty it is to issue patents on applications as described above, to issue all said Letters Patent to GPCP, as assignee;

AND ASSIGNORS HEREBY warrant and covenant that we have full right to convey the entire interest herein assigned and that we have not executed and will not execute any instrument or assignment in conflict with this Assignment;

AND ASSIGNORS HEREBY agree to communicate to GPCP or its representatives any facts known to us respecting said invention and/or Application, to execute all divisional, continuation, continuation-in-part, reexamination, reissue and foreign applications, sign all lawful documents and make all rightful oaths and declarations relating to said invention and/or Application, and to testify in any judicial or administrative proceeding and generally do everything possible to aid GPCP to secure full and complete protection for the invention and/or Application or that may be necessary to vest in GPCP the complete title to the invention and/or Application hereby conveyed and to enable it to record said title and enforce said Letters Patent in the United States or any foreign country when requested so to do by GPCP.

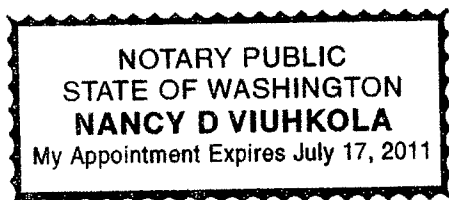

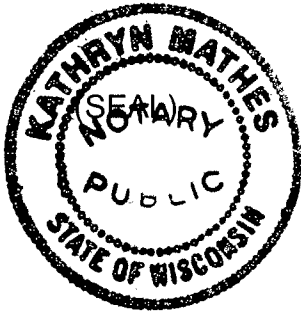

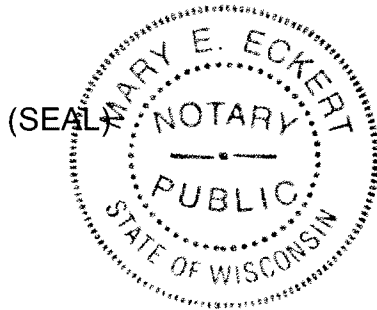
