SELL, ASSIGN AND TRANSFER to Covidien AG, a Swiss corporation having a place of business Victor von Bruns-Strasse 19, 8212 Neuhausen am Rheinfall, Switzerland ("ASSIGNEE"), effective as of 5 May 2008, the entire right, title and interest for the United States and all foreign countries in and to any and all improvements which are disclosed in United States Letters Patent 7,041,084, issued May 9, 2006, titled **HAND-HELD, HAND OPERATED POWER SYRINGE AND METHODS**, such patent and all divisional, continuing, substitute, renewal, reissue and all other applications for patent or the legal equivalent thereof which have been or may be filed in the United States and all foreign countries relating to any of such improvements, including Japanese Application No. 2002-591059 (Publication No. JP 2004527333) filed on May 23, 2002, European Application No. 02739370.1 (Publication No. 1399207) filed on May 23, 2003, and WIPO Publication No. WO 02/094343; all original, reexamined and reissued patents which have been or shall be issued in the United States and all foreign countries on such improvements; and specifically including the right to file foreign applications under the provisions of any convention or treaty and claim priority based on such application made in the United States;

AUTHORIZE the ASSIGNEE to apply for and receive any and all United States and foreign patents relating to such improvements in its own name;


AUTHORIZE AND REQUEST the issuing authority to issue any and all United States and foreign patents granted on such improvements to and in the name of the ASSIGNEE;

AGREE AND ACKNOWLEDGE that the SALE, ASSIGNMENT AND TRANSFER of rights and property set forth herein is and shall be IRREVOCABLE and BINDING upon the heirs, assigns, representatives and successors of each undersigned ASSIGNOR and EXTEND to the successors, assigns and nominees of the ASSIGNEE.

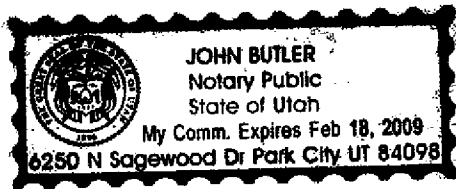


