INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (the "Assignment") is made effective July 11, 2008, by and between SITE PRO 1, INC., a New York corporation with an address of 15 Oser Avenue, Hauppauge, New York 11788 USA ("Assignor"), and PIROD, INC., a Delaware corporation with an address of 7002 North 288th Street, Valley, Nebraska USA 68064 ("Assignee").

WHEREAS, Assignor (i) is the owner of the trademark and the associated registration existing in the United States Patent and Trademark Office listed on Exhibit A attached to this Assignment and uses and claims common law rights to the trademarks and trade names listed on Exhibit B attached to this Assignment, including any and all derivations and logo styles used in connection with those trademarks and trade names (the "Marks"), (ii) is the owner of the U.S. Letters Patent existing in the United States Patent and Trademark Office and the Canadian patent existing in the Canadian Intellectual Property Office, both of which are listed on Exhibit C attached to this Assignment (the "Patents"), (iii) is the owner of certain copyrights existing in Assignor's product catalog, Internet Web sites and other marketing and advertising materials used in the Business (the "Copyrights"), and (iv) other intellectual property used in connection with the Business (collectively, the "Intellectual Property").

WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to said Intellectual Property.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest in the United States and Canada in and to said Intellectual Property, together with the goodwill of the business symbolized by the Marks and the Domain Name, any registrations or future registrations of the Marks and the Domain Name, any and all applications for patents and any and all patents resulting therefrom in any and all countries, including all divisions, continuations, reissues and extensions thereof, and all rights of priority resulting from the inventions described in the Patents, and all causes of action, past, present and future, related to the Intellectual Property. Assignee will determine, in its sole discretion, whether the Copyrights will be preserved and maintained or registered in the United States or any foreign country. Assignor further agrees to take all reasonable steps to effectuate the transfer of the Domain Name, including, but not limited to, requesting that GoDaddy.com, Inc. unlock the domain name and providing Assignee with the authorization codes. Capitalized terms used but not defined in this Assignment will have the meanings ascribed to them in the Agreement.
