ASSIGNMENT

WHEREAS, FREPAR NETWORKS KABUSHIKI KAISHA, a Japan Corporation, with its principal place of business at 13F Nissay Toranomon Bldg., 12-1, Toranomon 3-chome, Minato-ku, Tokyo, Japan; and SOMAR KABUSHIKI KAISHA, a Japan Corporation, with its principal place of business at 11-2, Ginza 4-chome, Chuo-ku, Tokyo, Japan, are the co-owners by way of Assignment from the inventors of the entire right, title, and interest in and to certain new and useful improvements in "DISPLAY APPARATUS," for which an application for Letters Patent in the U.S. Patent and Trademark Office was filed December 22, 2006, said Assignment being recorded by the Assignment Branch of the U.S. Patent and Trademark Office on March 12, 2007 at REEL/FRAME: 018996/0574;

NOW, THEREFORE, in good and valuable consideration, the receipt of which is hereby acknowledged, the said Assignor, does hereby acknowledge that the Assignor has sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto the said Assignee, its successors, legal representatives and assigns, the entire right, title, and interest throughout the world in, to and under the said improvements, and the said application and all divisions, renewals and continuations thereof, and all Letters Patent which may be granted for said improvements in all countries and all extensions, renewals and reissues thereof, and all rights of priority under International Conventions and applications for Letters Patent which may hereafter be filed for said improvements in all countries; and the said Assignor hereby authorizes and requests the Official of all countries, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND THE ASSIGNOR HEREBY covenants and agrees that the said Assignor will communicate to the said Assignee, its successors, legal representatives and assigns, any facts known to the said Assignor respecting said improvements, and testify in any legal proceeding, signs all lawful papers, executes all divisional, continuing and reissue applications, makes all rightful oaths and generally does everything possible to aid the said Assignee, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
