ASSIGNMENT OF APPLICATIONS FOR LETTERS PATENT
("Assignment") dated as of October 3, 2007, by LampDesk Corporation, a Delaware corporation ("Seller"), and Palm, Inc., a Delaware corporation ("Buyer").

WITNESSETH:

WHEREAS, Seller is the owner of its right, title and interest in, to and under the patent applications listed in Schedule A (collectively, the "Applications");

WHEREAS, Buyer is desirous of acquiring the Seller's entire worldwide right, title and interest in, to and under the Applications.

WHEREAS, Buyer and Seller have concurrently herewith consummated the purchase by Buyer of the Applications and certain other assets pursuant to the terms and conditions of the Asset Purchase Agreement dated as of the date of this Assignment between Buyer and Seller;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties, intending to be legally bound, agree as follows:

1. Seller does hereby sell, assign and transfer unto the Buyer its entire right, title and interest in and to the Applications and all letters patents in all countries of the world based thereon or corresponding thereto, and all divisional, continuing, continuation-in-part, and reissue applications therefor, and the patents which may be thereupon issued, including any and all rights to file applications and receive patents in all countries of the world, the same to be held and enjoyed by the Buyer to the full end of the term for which said letters patent may be granted, as fully and entirely as the same would have been held and enjoyed by Seller had this assignment and sale not been made; and Seller hereby agrees to sign all necessary papers and do all lawful acts reasonably requisite in connection with the prosecution, assignment, enforcement and disclaimer of each and every patent application based upon the Applications, without further compensation, but at the expense of the Buyer or its successors and assigns, and Seller assigns to the Buyer all rights to sue for infringement, including past infringement if any, of any patent based upon or corresponding to the Applications.

2. Seller does hereby authorize and request the officials of all countries in which the Applications will be issued to issue to the Buyer all of


Seller's entire right, title and interest in and to the same for the sole use and enjoyment of the Buyer, its successors and assigns.

3. This Assignment shall be governed by and construed in accordance with the law of the State of California, without regard to the conflicts of law rules of such state.

4. This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
