ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, I, **Stewart D. Lees** of Fife, United Kingdom (hereinafter called "the inventor(s)"), have invented certain new and useful improvements in **RADIO FREQUENCY DATA READER**, Docket No. **14461.00** (hereinafter called "the invention"), for which I have executed an application for Letters Patent of the United States of America (hereinafter called "the application") on same date herewith; and

FURTHER, I, the inventor(s), agree that I will communicate to NCR Corporation, or its representatives, any facts known to myself/us respecting the invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal, and reissue applications, execute all necessary assignment papers to cause any Letters Patent arising therefrom in the United States of America to be issued to NCR Corporation, make all rightful oaths and generally to do everything possible to aid NCR Corporation, its successors and assigns, to obtain and enforce protection for the invention in the United States of America and in any other countries in the world.

FURTHER, it is hereby declared that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value, of the consideration exceeds £60,000 (Sterling).
