ASSIGNMENT OF INVENTION AND OF LETTERS PATENT

WHEREAS, I, **Kapil Mohan Singh**, residing at 10007 Bent Creek Drive, Loveland, Ohio 45140, am a citizen of United States and have invented certain new and useful inventions or improvements relating to test to measure curling tendency of paper in laser printers for which I have executed an application for Letters Patent of the United States of America, entitled "TEST TO MEASURE CURLING TENDENCY OF PAPER IN LASER PRINTERS" filed on **November 10, 2003** and having been afforded serial no. 10/705,043 by the United States Patent and Trademark Office; and
