Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIFTH: The merger is to become effective on April 25, 2008.

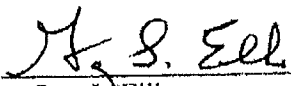
