PATENT ASSIGNMENT

WHEREAS, Charles C. Samman, an individual, Trace A. McGuire, an individual, and Richard Hefley, an individual (hereinafter collectively referred to as the "Inventors") have invented, and are named inventors of, LADDER AND RELATED METHODS (hereinafter referred to as the "Invention"), which is the subject of U.S. Patent Application No. 11/475, 662, filed June 27, 2006;
