ASSIGNMENT AND AGREEMENT

For good and valuable consideration, the receipt of which is hereby acknowledged, DMLS, has granted, bargained, sold, assigned, and fully and irrevocably transferred hereby unto, COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III, its successors, assigns, and legal representatives, the entire right, title and interest for the United States of America in and to any and all inventions relating to the application for Letters Patent, together with the entire right, title and interest in and to the application, and in and to Letters Patent which may be issued upon the application, and upon any division, extension, continuation or reissue thereof.

DMLS hereby also sells, assigns, and transfers unto COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III, the entire right, title and interest in and to the invention and in and to applications for Letters Patent therefore in all countries foreign to the United States of America, including all rights under any and all international conventions and treaties with respect of the invention and the applications for Letters Patent in foreign countries, and DMLS further authorizes COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III to apply for Letters Patent in foreign countries directly in its own name, and to claim priority of the filing date of the application for Letters Patent of the United States of America under the provisions of any and all international conventions and treaties.

DMLS hereby authorizes and requests the Commissioner for Patents of the United States of America to issue Letters Patent upon the aforesaid application, division, extension, continuation or reissue, to COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III, for the sole use and benefit of COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III, its successors, assigns and legal representatives, to the full end of the

term for which Letters Patent may be granted, the same as they would have been held and enjoyed by DMLS had this assignment not been made. DMLS further hereby authorizes and requests the equivalent authorities in foreign countries to issue the patents of their respective countries to COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III.

DMLS agrees that, when requested, DMLS will, without charge to COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III, but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for the inventions in any and all countries and for vesting title thereto in COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III, its successors, assigns and legal representatives or nominees.

DMLS covenants with COMPUCREDIT INTELLECTUAL PROPERTY HOLDINGS CORP. III, its successors, assigns and legal representatives, that the interest and property hereby conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance.

DMLS hereby ratifies and affirms that all acts that its attorney, agent, representative, substitute, or substitutes under it shall lawfully do by virtue hereof.

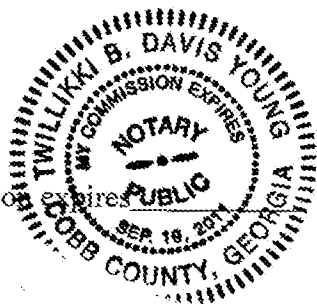
