
WHEREAS, Thomas F. Choate ("CHOATE") is the sole inventor of the inventions embodied in the patent applications listed in Schedule A; and

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:



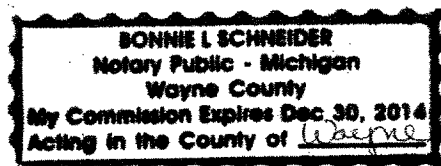
