PATENT SECURITY AGREEMENT

WHEREAS, JEFFREY L. VEY, an individual with a principal residence located in Texas ("Grantor"), either owns or may acquire certain rights in or to the patents and patent applications listed on Schedule A annexed hereto; and

WHEREAS, Grantor, Motor Trike, Inc., Thoroughbred Motorsports, Incorporated and Austin Bank, Texas N.A. - South Tyler ("Secured Party") are parties to a Security Agreement dated as of August 20, 2008 (as the same may be amended and in effect from time to time, the "Security Agreement"); and

WHEREAS, pursuant to the terms of the Security Agreement, Grantor has granted to Secured Party a security interest in the Property described in the Security Agreement, which Property includes, without limitation, each patent and patent application together with substitutions or extensions thereof; including all right, title and interest of Grantor in, to and under all now owned and hereafter acquired patents, patent applications and patent licenses, and all products and proceeds thereof, to secure the payment of all Secured Debts (as such term is defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby grant to Secured Party a continuing security interest in all of Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Patent Collateral"), whether presently existing or hereafter created or acquired:

- (1) each patent and patent application, including, without limitation, each patent and patent application referred to in Schedule A annexed hereto, together with any reissues, continuations, divisions, modifications, substitutions, or extensions thereof;
- (2) each patent license, including, without limitation, each patent license (if any) listed on Schedule A annexed hereto; and
- (3) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement of any patent, including, without limitation, any patent referred to in Schedule A annexed hereto, any patent issued pursuant to a patent applications referred to in Schedule A annexed hereto and any patent licensed under any patent license listed on Schedule A annexed hereto.

This security interest is granted in conjunction with the security interests granted to Secured Party pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Secured Party with respect to the security interest in the Patent Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
