AND said assignor hereby agrees to perform, upon the request of said assignee, or said assignee's successors or assigns, any and all acts relating to the obtaining or to the asserting of said patents, including any and all renewals, reissues, and prolongations thereof.

AND said assignor authorizes and requests the Commissioner of Patents and Trademarks to issue Letters Patents on said application, and on any and all divisions and continuations thereof,

to said assignee, and said assignee's successors and assigns, in accordance herewith.
