
ASSIGNMENT

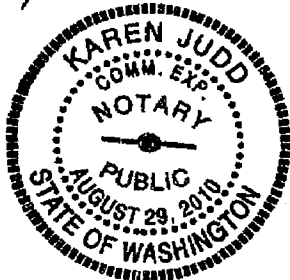


