ASSIGNMENT

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to said **FRITO-LAY TRADING COMPANY GmbH**, its successors, legal representatives, and assigns, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths, and generally do everything possible to aid the said **FRITO-LAY TRADING COMPANY GmbH**, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for said invention in all countries.
