ASSIGNMENT

WHEREAS, WE, SHIVA SHARAREH, MICHELE MIGLIUOLO, AND HIROSHI NAKAGAWA, residing at 27751 Daisyfield Drive, Laguna Niguel, California 92677; 2322 Sarah Street, Pittsburgh, Pennsylvania 15203; and 1216 North West 195th Street, Edmond, Oklahoma 73003, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **CATHETER WITH MULTIPLE MICROFABRICATED TEMPERATURE SENSORS**, filed November 15, 2005, Application No. 11/280,759, together with a claim to the priority of United States Provisional Application No. 60/628,442, filed November 15, 2004.

AND MICHELE MIGLIUOLO HEREBY covenants that he has full right to convey the entire interest herein assigned, and that he has not executed, and will not execute, any agreement in conflict herewith;

AND MICHELE MIGLIUOLO HEREBY further covenants and agrees that he will communicate to ASSIGNEE any facts known to him respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid
