ASSIGNMENT OF PATENT APPLICATIONS

Said INVENTOR hereby covenants that he has the full right to convey the entire interest herein assigned, and that he has not executed, and will not execute, any agreement in conflict herewith.


Said INVENTOR further covenants and agrees that he will communicate to TRUE SEATING CONCEPTS and to its successors and assigns any facts known to him respecting said DESIGNS, and at no expense to himself, testify in any legal proceeding, sign all applications, make all rightful oaths, and generally do everything reasonable to aid TRUE SEATING CONCEPTS and its successors and assigns to obtain and enforce proper patent protection for said DESIGNS in all countries.

Said INVENTOR acknowledges that this Agreement does not apply to any invention which qualifies fully under the provisions of Section 2870 of the California Labor Code, which states that:

Any provision in an employment agreement which provides that an employee shall assign, or offer to assign, any of his or her rights in an invention to his or her employer shall not apply to an invention that the employee developed entirely on his or her own time without using the employer's equipment, supplies, facilities, or trade secret information except for those inventions that either:

1. Relate at the time of conception or reduction to practice of the invention to the employer's business, or actual or demonstrably anticipated research or development of the employer.
2. Result from any work performed by the employee for the employer.
