**ASSIGNMENT OF PATENTS**

**(HP to RRT)**

Except for the patents listed in Exhibit AI, the foregoing assignment does not include any patents, and other intellectual property that are presently assigned of record to HP and its predecessor entities and their affiliates. And HP, for itself, and its heirs, assigns, and legal representatives hereby further covenants to and with said assignee




Purchaser, its assigns, successors, and legal representatives to fully cooperate therewith in perfecting this assignment in the United States, and including the execution of additional assignments or other formal documents as may be required in connection therewith.


