I hereby authorize and request the Commissioner of Patents of the United States to issue all Letters Patent based on said application and all said divisions, continuations, continuations-in-part, reissues, renewals and extension to said ASSIGNEE, its successors and assigns.

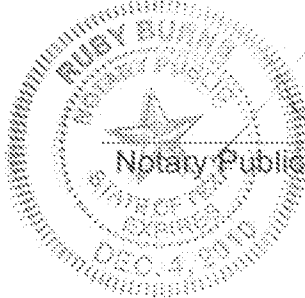
