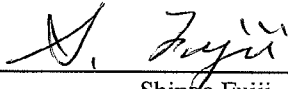

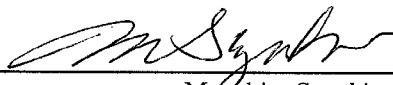

Die BASF SE ist deshalb Rechtsnachfolgerin der BASF Aktiengesellschaft.

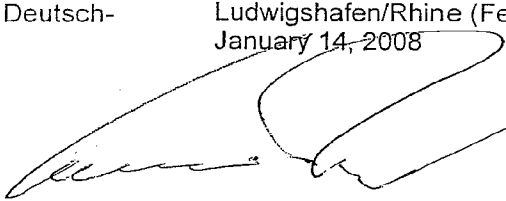

BASF Aktiengesellschaft with registered office in Ludwigshafen am Rhein, Federal Republic of Germany, was registered in the form of a stock corporation [Aktiengesellschaft] in the commercial register of the district court -court of registry- in Ludwigshafen am Rhein, Federal Republic of Germany, under the entry number HRB 3000 until January 14, 2008.
2. **BASF SE**
As resolved by the Annual Meeting of Shareholders on April 26, 2007, BASF Aktiengesellschaft has been converted by way of change of legal form pursuant to the Conversion Plan of February 27, 2007 into BASF SE with registered office in Ludwigshafen am Rhein, Federal Republic of Germany.
BASF SE with registered office in Ludwigshafen am Rhein, Federal Republic of Germany, is registered as from January 14, 2008 in the legal form of a Societas Europaea in the commercial register of the district court - court of registry - of Ludwigshafen am Rhein, Federal Republic of Germany, under the entry number HRB 6000.

Therefore, BASF SE is the legal successor of BASF Aktiengesellschaft.

As set forth in Art. 37 para. 2 of Council Regulation (EC) No. 2157/2001 of October 8, 2001 on the Statute for a European Company (SE) this conversion neither resulted in the dissolution of the company nor in the establishment of a new legal person.

3. **Confirmation**
Based on today's inspection of the commercial register, I, Notary public, certify the aforescribed legal succession.
