



Humphrey**, do hereby sell, assign and transfer to **BINS, LLC** the entire and undivided right, title and interest in and to our inventions of new and useful improvements in and to a “**Cargo Carrying Vehicle and Method of Operation**”, a “**Method and Apparatus for Unloading Container**” and a “**Vehicle Having Loading and Unloading Capabilities**”, said patent applications, the inventions therein described, and all rights appurtenant thereto and in all our applications related thereto, including each of the following: the right to apply for any letters patent for said inventions in the United States of America and in any and all foreign countries, any and all other applications for letters patent on said inventions, in whatsoever countries, including all divisional, renewal, substitute and continuation applications based in whole or in part upon said inventions or upon said patent applications or related thereto; any and all letters patent that may issue thereon in the United States and foreign countries and any and all reissues, extensions, renewals, divisions, or continuations of letters patent granted for said inventions or upon said applications, to the full end of the term or terms for which said letters patent may be issued; and every priority or other right accorded by every international convention, treaty or agreement that is or may be predicated upon or arise from said invention, application and other applications or letters patent therefor, all to be held by **BINS, LLC**, and its successors and assigns, all the same as we would have held and enjoyed had this Assignment not been made.

We hereby represent and warrant that there are no outstanding rights or interest inconsistent with the rights and interests granted herein; We covenant that we will not execute, grant, or transfer any rights or interests inconsistent herewith; We bind ourselves, our heirs, executors, administrators and legal representatives to execute and deliver to **BINS, LLC**, and its successors and assigns, any further documents or instruments and to perform any and all further acts that may be deemed necessary to enable it, and its successors and assigns, to file applications for letters patent for said inventions in any country in which it may elect to file such applications, and to vest in **BINS, LLC**, and its successors and assigns, the title herein conveyed and intended to so be, and to enable such title to be recorded in the United States and each foreign country in which each such application may be filed so that any patent issued thereon shall be issued to vest in **BINS, LLC**, and its successors and assigns; and we further covenant and agree, for ourselves and our executors, administrators and legal representatives, that we and they will, upon request, communicate to **BINS, LLC**, and its successors and assigns, any facts relating to said invention and the history thereof, known to us or them and that we and they will testify as to the same in any proceeding, interference or litigation when requested to do so by **BINS, LLC**, and its successors and assigns.
